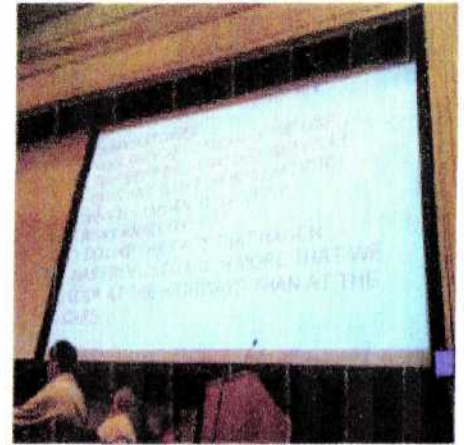

Communication Access Realtime Translation (CART) is the instant translation of the spoken word into English text using a stenotype machine, notebook computer and realtime software. The text may be displayed on a computer monitor for individual viewing, projected onto a large screen for audience viewing, or sent via an encoder to provide closed/open captioning for television broadcasts.

This technology is primarily used by people who are late-deafened, oral deaf, hard-of-hearing, or have cochlear implants. Culturally deaf individuals also make use of CART in certain situations. Please keep in mind that CART is also often referred to as realtime captioning.
