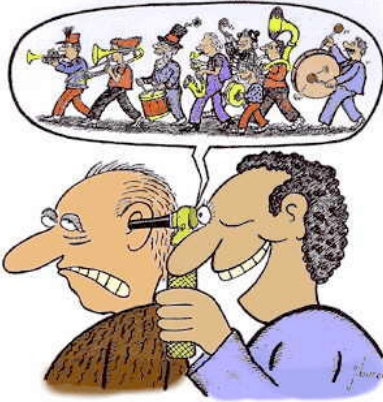

Call it tin-EYE-tus or TIN-it-us, it's still very, very annoying

If you hear ringing, hissing, buzzing, humming, chirping, or other noises in your ears or head, it is called tinnitus and pronounced either TIN-it-tus or tin-EYE-tus, either is correct.



Most cases of tinnitus are subjective, that is perceived only by the person with the disorder and not necessarily generated by any outside noise source.

Tinnitus can result from damage anywhere along the auditory pathway. Therefore, it is often difficult to find the

cause and suitable treatment. It is well known that exposure to loud noise can result in tinnitus and make it worse. Other common causes include:

- Wax pressing on the ear drum
- Meniere's disease
- Otosclerosis
- Acoustic neuroma
- Inherited abnormalities of the ear
- Diabetes which may result in a sensorineural hearing loss
- Strained muscles of the neck from arthritis, whiplash, clenching one's teeth or temporo-mandibular joint dysfunction (TMJ)

- Scuba Diving
- Ototoxic medications
- High blood pressure
- Diet/smoking
- Stress

Much can be done to provide treatment for tinnitus. No longer is it necessary to "just go home and live with it." If you experience tinnitus, you should be certain to mention it to your family physician who may then refer you to an otolaryngologist (ENT doctor) and audiologist for further evaluation and care. Treatment options may include:

- Medications
- Masking
- Hearing aids (if a hearing loss accompanies tinnitus)
- Biofeedback
- Acupuncture
- Hypnotherapy
- Stress reduction
- Diet modifications

Joan Andrews Scholarship Award

The Hearing Loss Association of Florida announces the second annual *Joan Andrews Scholarship*. Joan Andrews, former president of the Florida Association of Self Help for Hard of Hearing People, now known as the Hearing Loss Association of Florida, worked tirelessly to improve the quality of life for individuals with hearing loss. The Scholarship will be awarded to an individual who demonstrates in writing (by completion of the application process) a sincere educational interest in and commitment to sharing the mission of the Hearing Loss Association with others affected by hearing loss. The Selection Committee will give priority consideration to an applicant who meets all the criteria as set forth in the application process AND who cannot afford to attend the HLA convention without the assistance of this scholarship.

SCHOLARSHIP DESCRIPTION: The scholar-

ship will entitle the winner to a registration to the Hearing Loss Association of America convention in Milwaukee, WI from June 17-20, 2010. The scholarship will also include a room at the convention hotel for three nights and round trip airfare or automobile travel expense between Florida and Milwaukee, WI. The maximum value of the scholarship is \$1,000.00. The winner is responsible for making all travel, hotel and convention registration arrangements.

ELIGIBILITY: An applicant must be a Florida resident and member in good standing of the Hearing Loss Association of America. Current members of the HLA-FL Board of Trustees are not eligible.

FTRI promotes its services throughout the state by making face-to-face presentations as well as providing on-site equipment distributions. At on-site equipment distributions, FTRI typically partners with local service providers such as professional hearing health-care specialists or audiologists to provide free hearing screenings to those interested in receiving a **free** amplified telephone. Now is the perfect time to get the H1N1 flu vaccine

Flu season is in full swing, and with the Centers for Disease Control and Prevention (CDC) recently announcing that one in six Americans has already suffered from the H1N1 swine flu, now is the perfect time to get vaccinated.

County health departments, private health providers and pharmacies throughout Florida initially offered the H1N1 flu vaccine to specific priority groups, yet many are now expanding the availability of vaccine to everyone who wants to receive it. Vaccination is your best protection against the H1N1 swine flu.

H1N1 vaccine is manufactured and tested using the same process used for seasonal flu vaccine, which has a strong and proven safety track record.

It is important for Floridians to get the vaccine when it becomes available, as the number of cases, hospitalizations, and deaths due to H1N1 continue to rise, and we are approaching the peak of our annual flu season. To date, 1,159 hospitalizations and 180 deaths from the H1N1 virus have been reported across the state.

Triple feature program at HLA-Sun City Center

The Sun City Center, Florida chapter of the Hearing Loss Association of America (HLA-SCC) held a successful triple feature program on December 2.

The guest speaker was Deputy M. Tierney (Hillsborough County) who addressed HLA-SCC members/guests about steps to take in bridging the communications gap if a person with hearing loss driving an automobile ever happens to be pulled over by the police.

A representative of The Bolesta Center, Inc., in Tampa spoke as well. Bolesta utilizes an auditory-based learning method delivered by certified Listening and Spoken Lan-

Whether it has been breaking down barriers or establishing a new status quo, these Trailblazers have improved the overall quality of life for all people with hearing loss. Ashley, along with nine other visionaries nationwide, has been chosen as one of this year's finalists. Each finalist was awarded a \$1,000 cash prize from Purple Communications to be donated to a non-profit organization of their choice, and in their name as a way of paving the way for the next generation of trailblazers in the Deaf and Hard-of-Hearing Community.



Accepting the \$1,000 award on behalf of HLA-Florida were board members Don Shaffer, Kay Shaffer, Larry Kavanaugh and Richard Herring. Ashley's interest in motocross began at the early

age of four at a race with her father. Fast forward nine years to age thirteen and she won the first of her many accolades - the Air Nautiques Loretta Lynn Amateur Nationals, deemed the biggest race in amateur motocross. In 2005, Ashley became the first female to qualify in the boy's class, placing 11th among 42 boys, and shattering the once held stereotype that girls couldn't make it in boy's motocross. Most recently, the 2009 WMX Champion was featured in *ESPN The Magazine* and was one of four nominees vying for a coveted *ESPN ESPY Award for Best Female Action Sports Athlete*. Ashley says, "I want to give back to the Deaf and Hard-of-Hearing Community as much as I can." She continues, "Who knows? Maybe I'll inspire someone who I'll end up racing against some day!"

The Story of HLAA - Sun City Center Chapter

During the summer of 2007, Robert Ogg, Shirley Nauman, and Richard Herring first met at Shirley's residence to explore the formation of a Sun City Center chapter of the Hearing Loss Association of America where many senior citizens with hearing loss lived either as snowbirds or full time residents. All three were long time members of a national organization known as Hearing Loss Association of America (HLAA). To be a member of HLAA was necessary in order for one to meet its requirements to form a chapter; thus, the Sun City Center (HLA-SCC) chapter was on the verge of being started.

HLA-SCC is a 501(c)(3) non-profit organization which adopts HLAA's mission of opening the world of communication to people with hearing loss by providing information, education, advocacy, and support. HLAA is an umbrella organization and has non-profit status. More information about HLAA is available on www.hearingloss.org.

One individual, Tess Crowder of Communication Access, Inc., skilled in Computer Assisted Realtime Translation (CART), typed on her laptop computer all the words being spoken during a public meeting so that one could view from a larger screen what was being said. CART was provided *pro bono* at HLA-SCC monthly meetings so that all would have communication accessibility. Another individual, David Houck, member of the Men's Club in Sun City Center was instrumental in securing funding for HLA-SCC to use for incidentals from his club.

An HLA-SCC steering committee was formed to meet monthly to become a chapter resource and offer valuable advice such as names of possible speakers, topics for discussion meetings, communication accessibility, contacts, and assistance as needed. Members of the committee are Robert Ogg, President; Richard Herring, Vice President; Shirley Nauman, Vice President of Publicity; David Houck, Treasurer; Gen and Jim Forceia, Bill Cozby, Ken Gleason, Barbara Riley, Marilyn Balkany, and Will Jansen. Without the inspiration from all of the members, the HLA-SCC would never have materialized in keeping with the mission of the national HLAA which was headquartered in Maryland.

The first public program meeting of HLA-SCC took place on October 3, 2007 at St. Andrew Presbyterian Church's Fellowship Hall. The church agreed to allow use of its facilities at no charge. Incidentally, five members of the HLA-SCC chapter steering committee were members of St. Andrew. The first speakers on October 3 consisted of member friends of the HLA-Sarasota chapter. The meeting was a huge success with 70 + individuals from the public in attendance.

This all happened when someone asked the question, "Why can't we have an HLAA chapter in Sun City Center?"

Going Deaf

No matter how she tilts her head to hear
she sees the irritation in their eyes.
She knows how they can read a small rejection,
a little judgment, in every *What did you say?*
So now she doesn't say *What?* or *Come again?*
She lets the syllables settle, hoping they form
some sort of shape that she might recognize.
When they don't, she smiles with everyone else,
and then whoever was talking turns to her
and says, "Break wooden coffee, don't you know?"
She pulls all she can focus into the face
to know if she ought to nod or shake her head.
In that long space her brain talks to itself.
The person may turn away as an act of mercy,
leaving her there in a room full of understanding
with nothing to cover her, neither sound nor silence.

Veterans Day

Hundreds of visitors and participants ignored the drizzling rain and an overcast sky to

attend November's Veterans Day celebration at Kanapaha/Veterans Memorial Park, where an addition to the park's memorial was unveiled. It lists the names of six Alachua County residents who have died in Afghanistan and Iraq as part of Operation Enduring Freedom and Operation Iraqi Freedom.

All branches of the military and all ages were represented at the ceremony. Children and pets played in outfits of patriotic red, white and blue. Many veterans sported caps and t-shirts about where and when they had served, while others suited up in uniform.

World War II-era aircraft flew overhead, ending their appearance with the aerial salute known as the *missing man formation*. One plane pulled away, trailing smoke, as the other two continued south.

A Retired U.S. Army Captain, wounded by a roadside bomb in Iraq that cost him his right leg, thanked older veterans "for paving the way for our generation of veterans."
